Information for Applicants

Membership

Ordinary Member: Organisation holding Queensland Government *Business Certificate to Perform Prescribed Activity* specifying Type of Work as Demolisher or Asbestos Removalist;
or
Organisation holding Queensland or Local government licence or certification for recycling activities.
An Ordinary Member is entitled to vote at general meetings and is eligible for election to the Management Committee.

Associate Member: Organisation whose business activities are related to demolishing, recycling or asbestos removal.
An Associate Member is not entitled to vote at general meetings and is not eligible for election to the Management Committee, however input into discussions is encouraged.

Meetings

- The Management Committee is comprised of six members and meets every 5-6 weeks.
- General Meetings/Information Forums (for all members) are held at such intervals as to provide members with timely information and enable voting on matters arising.
- Sub-committees/working groups may be established as required for specific objectives and projects.

Member Responsibilities

- Adhere to the Code of Conduct and Code of Best Practice.
- Attend and participate in meetings and information forums.
- Advise DRACAQ management of any matters which may impact on the organisation's objectives and/or activities.
- Promote DRACAQ and its objectives in a positive manner.
- Pay membership fees in a timely manner.
- Respond promptly to requests from the association for information/assistance.

Objects

The objects of the association as specified in the Rules of Association are -

- (a) To act as the representative body for member demolishers, recyclers and asbestos contractors in dealings with government and regulatory authorities, other industry sectors and the general public.
- (b) To promote and seek the recognition of members as professionals, and to promote public awareness of the demolition, recycling, asbestos removal and associated industries.
- (c) To improve the standard of operational practices within the industry for the benefit of workers and the protection of public health and safety.
- (d) To provide members with specific information to enhance work practices, including workplace health and safety, and industrial relations information.
- (e) To adopt and promote a code of conduct for the guidance of members as to the proper professional conduct within the industry.
- (f) To promote interest in, and progress of, any matter which will improve the technical and general knowledge and efficiency of the industry.
- (g) Such other objects as the association may from time to time determine.
